Checklist of Steps to view case records and court hearings-District and Superior

- GO TO <https://cp.spokanecounty.org/courtdocumentviewer/default.asp>
- Click "Accept" then choose District or Superior Court

In the District Court dropdown choose:	In the Superior Court dropdown choose
(for DVPO or criminal cases)	Cases By Name (family law/DVPO)
Cases By Defendant Name Criminal, Infraction, and Protection Orders	Civil Domestic Probate
	Cases By Defendant Name (criminal) Criminal

- Enter yours or the respondent/defendant's name.
- A list of available cases will be generated.
- Once you find the case you are seeking, click on the link.
- On this page you should see the court information, case number, status, etc at the top.
- Then in bold you will see the following columns:
  - **SUB#** - The number of the document and order of filing
  - **FILE DATE** - date document filed in court
  - **DOCUMENT DESCRIPTION** - description
- Scroll down to **Case Documents**
- There is an additional column with hyperlinked information: **View Doc**
- If you select, you will see the scanned in document to view by page - Note that some documents may not be scanned in, or *if it is a new case, documents may not yet be available.*
- You will be able to view by page, see top buttons above image "**first**" "**prev**" "**next**" and "**last.**"
